Tapping into the Partners' expertise, SEA will continue to help support its Members' sport and climate journeys. This will be fostered through the newly established quarterly Partner advisory meetings.

TO ENGAGE THE GLOBAL MOVEMENT

SEA celebrated seven years of cultivating respect for the natural world, encouraging and supporting leadership and action from the sport community in Australia and New Zealand.

SEA participated in numerous domestic and international forums and events and continued to grow its online presence, sharing stories and celebrating all the environmental efforts and achievements of the SEA network and beyond.

WHAT WAS LEARNED

During a continued time of uncertainty, which made climate planning and action difficult, SEA had to remain flexible in its approach.

The organisation had to adapt and learn how to deliver a game plan that ensured Members and the broader SEA community could continue working on what counts – protecting our places of play – while facing both lockdowns and the eventual opening of both Australia and New Zealand post COVID-19.

SEA also learnt that although change can be challenging, and the first step is hard, it is always worth it to embrace, be adaptable, flexible and agile.

CHAIRPERSON'S REPORT

2021/22 began as the previous year ended: in the grip of the pandemic with the attendant trials and tribulations felt by so many in a multitude of ways. Nonetheless the team at SEA, directors, staff and volunteers soldiered on to continue SEA's work to make sure that whatever could be done to help sports adapt and change to mitigate their footprints would be done. Preserving and protecting places to play is what SEA is all about.

The highlight of the year was the SEA Summit held on 3 March 2022 at the MCG for the first time since 2019. This excellent day commenced with a smoking ceremony in Yarra Park before a range of people from across sport and business discussed so many ideas about what can be done to help sport organisations do what they can to preserve the world we want and expect to continue to live in. Congratulations to the SEA Changer Award winners Australian Grand Prix Corporation in the SEA Member category and Oaks Cypress Lakes Resort Golf and Country Club in the non-Member category, and of course to judges Layne Beachley AO, Damon Gameau and Ciaran McCormack.

SEA held its biggest AGM so far at the end of 2021, online as it was. As a prelude to the meeting a Panel was held and the audience was delighted to hear from Dr Maddy Orr, Co-Convenor of Sport@COP, Matthew Campelli, Director of Sustainability at Touchline and Julia Pallé, Director Sustainability at Formula E.

Departing the Board were Eliza Newnham, Peter Wearne and Matt Green and they are once again thanked for their contribution to the growth of SEA during their respective tenures. Seeking re-election were Tiffany Cherry and Sandra Loader. Sandra was re-elected and was joined by new directors Neil Dalrymple, Amie Wallis, Tracey Gaudry and Cassandra Hadson. Continuing directors were Adam Luscombe, Margot Foster and Charlotte Hayes who replaced Natalie Bhardwaj as Treasurer in August 2021.

Thanks also to Natalie who did a marvellous job in wrangling the finances and directors particularly appreciated her graphic explanations of the financial reports.

Other than the elections the meeting approved a new, more coherent Constitution for SEA.

Dr Sheila Nguyen resigned as CEO effective mid April 2022 and thanks are extended to her for her vision and commitment to the idea for and then the execution of SEA, the world recognised organisation that it now is. As one of the Founders she retains her position as director on the Board. Her place was filled on an interim basis by SEA Legal Adviser Jack Peterson until the appointment of Consultant CEO Katherine O'Regan on 1 July 2022. Thanks to Jack for holding the fort and maintaining an even keel in his dual roles of lawyer and administrator for SEA.

An annual report is not only a time to summarise the year but to thank the many supporters of SEA. Members, Associate Members, Partners, Friends of SEA and Ambassadors are the lifeblood of what SEA is and does because they believe in what SEA does and want to be part of a future where anyone who wants to can play sport, unhindered by the challenges of hostile environments. You know who you are and you know where we can find you: listed on pages 11-13 of this report.

The year ahead presents opportunity aplenty as SEA looks to consolidate its wins, increase its membership and reach, and plans for the post-pandemic world where, because of the plague, we've become so much more closely connected and no one is out of touch or out of reach if an idea is to be shared or a thought planted. In this year, another milestone was achieved- my tenure as CEO came to its conclusion in April 2022.

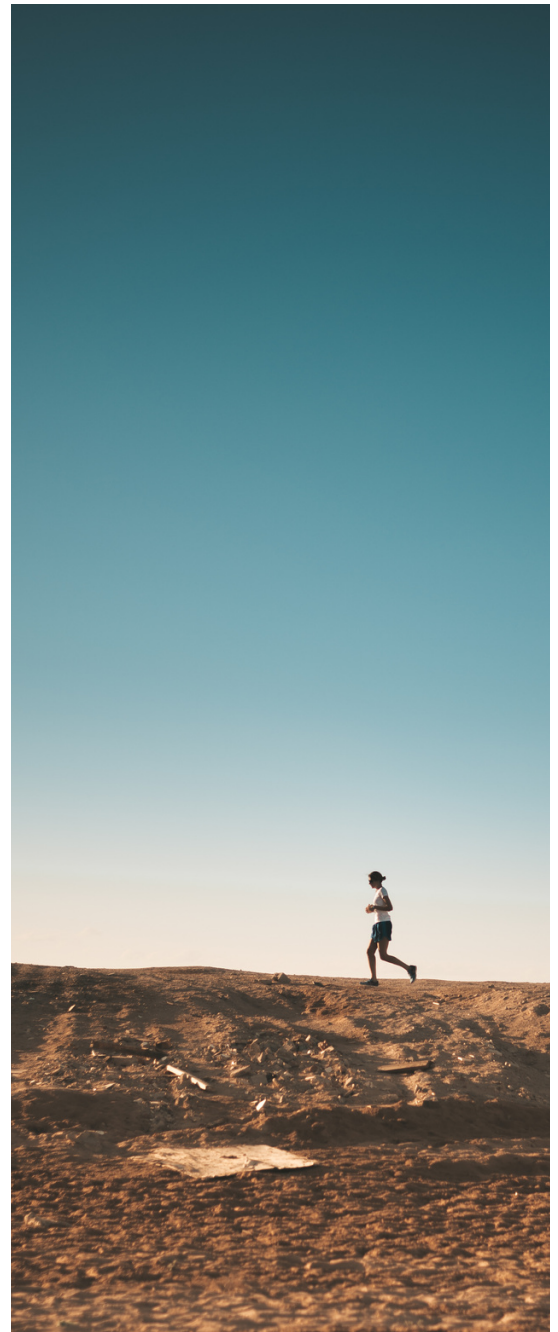

THE HIGHLIGHTS

2021-2022



As SEA entered the FY2021/22, the world was still in the throes of Covid-19. SEA's way of dealing with the uncertain environment was to focus on the future and the theme of 'Build your Game Plan.'

Over the course of the year, SEA held 20 events with contributions from across the SEA network including Members and Partners nationally and internationally.

Commonwealth Climate Conversations

SEA continued its quarterly sessions with UK-based British Association for Sustainable Sport (BASIS) to encourage further dialogue between the networks that share a Commonwealth sport culture.

Candid Climate Conversations

At SEA's first Candid Climate Conversations attendees heard from SEA Ambassador and Olympic Race Walker Rhydian Cowley about his 2021 Olympic experience. Hosted by Tiffany Cherry,

attendees learnt about Rhydian's career, his passion for the environment and how climate change impacts athletes and sport.

Formula 1 Sustainability Pod

During the Formula 1 Australian Grand Prix, the Australian Grand Prix Corporation in collaboration with SEA hosted round table discussions at the Sustainability Pod, a space for small round table discussions focused on creating transparency around the topic of sustainability. Over four days, The Pod hosted change makers from a range of industries to discuss and explore the macro and micro issues facing industries on their sustainability journey.

Sport@COP

Although SEA staff could not be there in person, it was with great pride that SEA (virtually) represented the Australian and New Zealand sport and climate movement (with its international allies) at COP26. Aside from showcasing SEA Members' amazing work and sharing in the discussions, SEA co-founder Sheila Nguyen also served as a judge in the first SPORT@COP Hackathon.

SEA Summit

After many false starts, SEA held its first (in-person) SEA Summit since Covid-19 at SEA Member Melbourne Cricket Ground.

The SEA Summit was focused on the theme of the 'Planet Champions Game Plan' and breaking down the journey of efforts into the representative quarters of the journey most of SEA's community take to achieve empowerment to do more {for the world} with less {footprint}.

The SEA Team curated the agenda to help delegates to:

- Get a strong sense of what their planet journey requires
- Have the space to connect with the right people who might likely be part of their #OnePlanetTeam
- Showcase, share, and celebrate all the good work that the sports industry and community do.

19 speakers contributed to the agenda, to name a few: Neil Dalrymple (Bowls Australia), Warwick Waters (Australian Olympic Committee) and Simon Matthews (Richmond FC). International contributors included Lee Spivak (Waste Management Phoenix Open) and Caroline Carlin (Southampton FC).

SEA Changer Awards

The winners of the SEA Changer Awards were announced, judged by Layne Beachley (seven-time World Surfing Champion), Damon Gameau (2040), and Ciaran McCormack (Climate Reality Project). SEA member finalists were Victoria Racing Club, Motorsport Australia and winner Australian Grand Prix Corporation, Non-SEA member finalists SportENG on behalf of Waverley Netball Centre and winner Oaks Cypress Lakes Resort, Golf and Country Club.

The SEA Summit was attended by 114 delegates and 18 digital attendees.

DIGITAL MEDIA

2021-22

During the 2021/22 financial year, SEA's social media following grew (organically) by 43 percent, to a total of over 5000 followers across Facebook, LinkedIn, Twitter and Instagram.

The total potential reach, which includes the following and reach of the wider SEA network (Ambassadors, Members, Partners, and Associate Members) peaked at an impressive 14 million.

As SEA's social media reach grew, the type of content that was distributed was fine-tuned, with a focus on delivering customised and tailored experiences across each platform. The goal to diversify and reach more people via different channels was met.

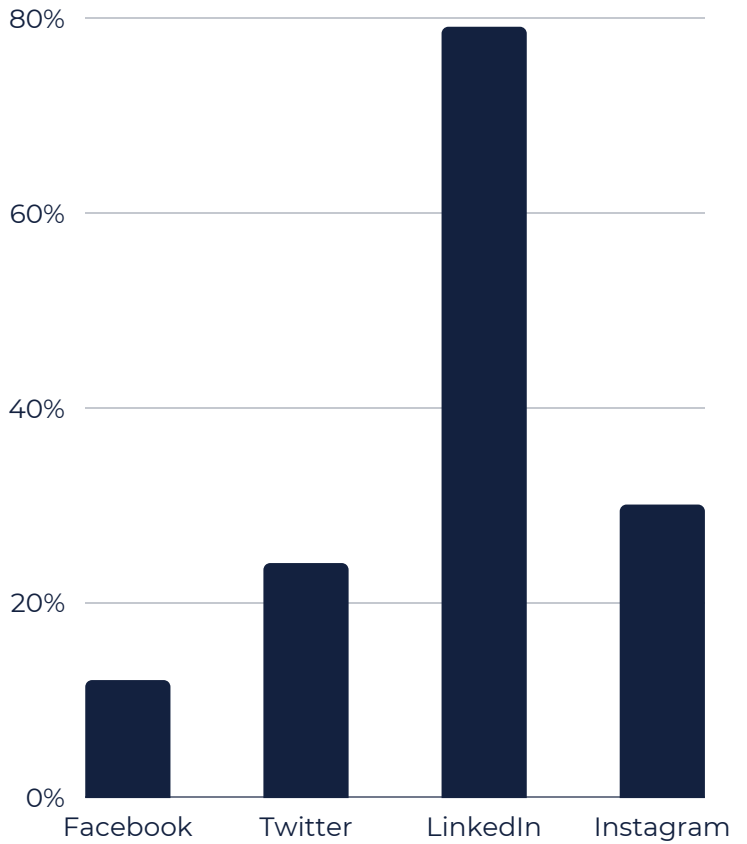


Figure 1. Percent increase of followers across platforms; annual figures.*

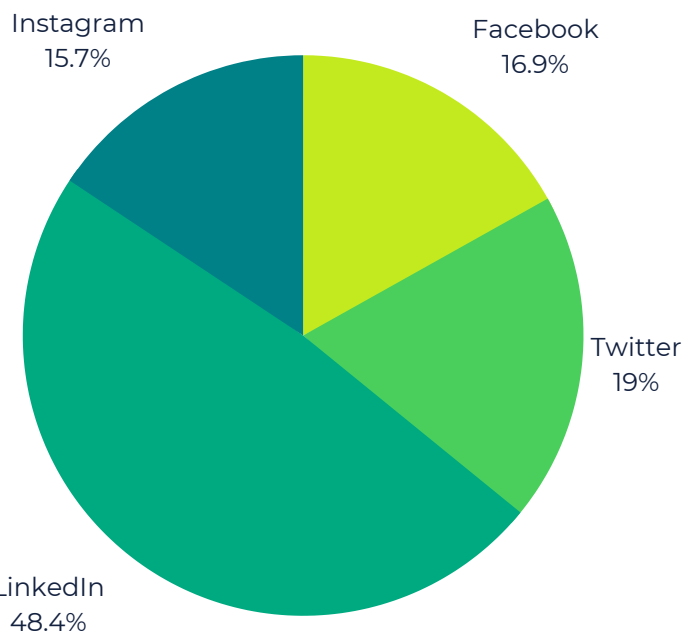


Figure 2. Number of followers across SEA's social media platforms; percent of total presence.*

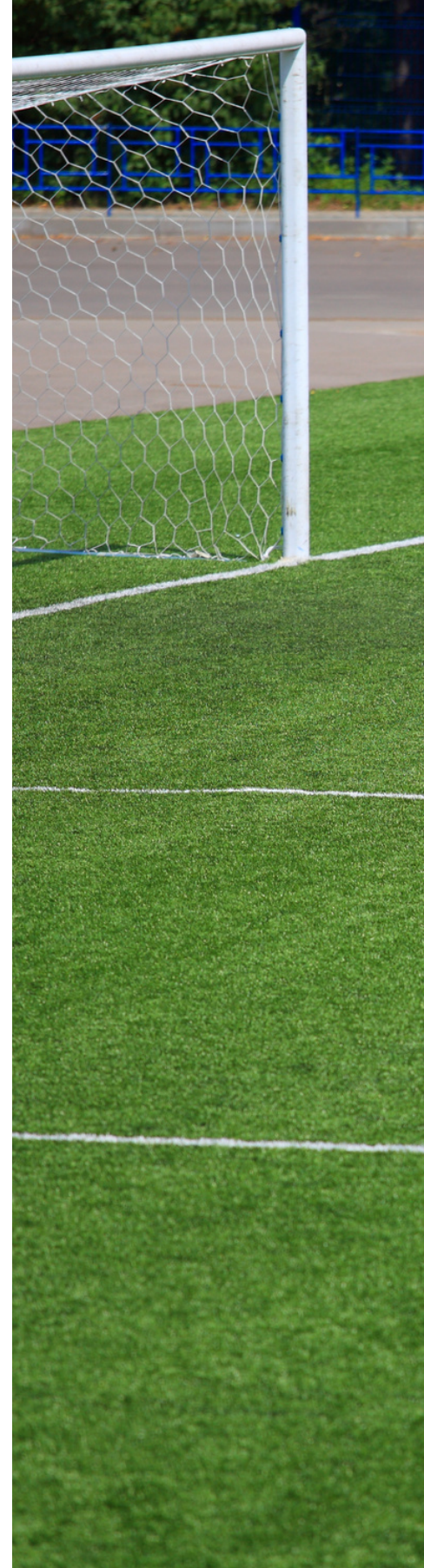

FINANCIAL SUMMARY

Another challenging year for all Not-For-Profits and SEA was certainly not exempt from this. However, continued responsible fiscal management meant that SEA was able to deliver a surplus for the 2022 financial year, whilst maintaining a strong balance sheet position.

We were thrilled to be able to host the SEASummit and Awards Ceremony in person, at the iconic MCG, which could not have been possible without the wonderful support of our partners.

As sporting organisations make hard decisions about where to invest limited funds, SEA membership fees have remained buoyant, from existing and new members. Partnerships are vital to SEA being able to drive change and we have welcomed several this year, and SEA has continued to provide consulting services to clients looking to expand on their environmental capability. Victorian Government support grants continued to provide much needed support for the SEA team.

The 2021-2022 FY result was a profit of \$14,016.

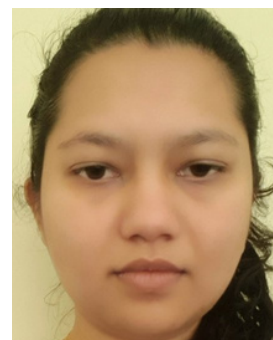
