3. PRESIDENT'S REPORT

1. INTRODUCTION

This has been a year of consolidation; our Coaches and Umpires Commissions are now fully functional and doing some great work. Our on-line members portal is now operating well and is being used constantly by our membership. We held our third Easter Carnival which was a great success with record numbers of entries

During the year Leo Prior resigned from the Board for health reasons. We did not replace him immediately as there was only approximately three months to the AGM.

At the coming AGM Andre Deramond will be standing down from the Board and in accordance with the Constitution will not be seeking re-election having completed three consecutive term on the board and Gerrard Finette will also complete his term and will be seeking re-election. There are three vacancies and we have three candidates

2. COMMUNICATIONS

This year we will be looking at moving to an Internet-based commercially-developed suite of programmes for all of our data processing, membership admin, player licencing and competition administration. This will develop over the coming year and we will keep you fully up to date with progress

3. MEMBERSHIP

Our membership numbers are almost the same as they were this time last year with 1619 current members. Following the licence renewals in July we had a marked drop in membership probably a result of our ageing membership. However, during the year we have had strong membership growth with close to 100 new members and 3 new clubs, so things are looking quite good at present

4. NATIONAL UMPIRING

Continuation of the task by PFA to increase its number of umpires in Australia we have now reached 50 umpires but still struggling to fulfil the PFA recommendation to have an umpire per club of 30 members+.

Each league has conducted workshops to increase the number of umpires with more or less success.

Leo Prior our Administrative Director of umpiring had to retire due to ill health. Leo has been of a great support compiling all records for PFA. Ray Beaumont as accepted to take over role.

New umpire workshops to be conducted in the ACT and QLD in early July 2020

The PFA Umpire Commission has reviewed and published a series of documents

- Umpires handbook
- Umpires code of conduct
- Tournament Director's Guidelines

All those documents have been posted on PFA website and are available for all to consult.

5. COACHING

PFA coaches have been active within their State conducting training sessions and our National coaches have taken our teams overseas to world championships (Canada and Cambodia). They should be congratulated on their effort and contribution.

PFA coaches were also involved in the Trans-Tasman in Newcastle and the Interstate Challenge in Adelaide.

Our coaches are doing the job on a voluntary basis and at their own expenses.

Patrick Dufresne and Gerard Finette will be conducting coaching accreditation courses in July 2020 in ACT, QLD, WA and VIC

Our Selection Panel, which is made up of coaches from all states, operates in accordance with the PFA Selection Policy. The panel which is chaired by Adrian Clements has been in operation for the last three years. Last year the panel was responsible for the selection of a number of very successful Australian Teams.

6. STATE LEAGUES

Due to the Oceania Championship which took a lot of organising we were unable fit another joint meeting with the State Leagues. However, we were very pleased with the outcome of the first meeting and will definitely be looking to organise another meeting with State Leagues this year

7. INTERNATIONAL EVENTS

Last year Australian teams represented Australia in international competitions

- Pan Pacific in Noumea New Caledonia
 - Our 2 teams competed well against strong local players and gave a good account of their abilities
- Oceania Championships were held in Australia Caulfield Park Petanque club
 - Australian men's team failed to qualify for the world championships in Switzerland July 2020
 - Our women doubles won the Gold medal a great result
- World Women championship in Cambodia
 - Too difficult in particular the Asian countries and the top European nations

8. NATIONAL COMPETITIONS

The ISC competition finals were played at Eastern Suburbs Petanque Club in Adelaide on the first weekend in September.

The top open and 0'60 teams from each State played off for the trophy. The competition was tough with teams from Victoria, NSW, WA, TAS and SA taking part. The open competition was won by WA, and the O' 60s competition was won by TAS. TAS being undefeated in the 0'60.

This year the competition has been revised to become the Interstate 6, in which teams of 3 men and 3 women in both open and O'60's categories will play off over 2 days. State leagues will nominate their teams to represent each state, the final will be held in September at a venue which is still to be selected.

Easter National Carnival of Petanque was held for the third and final time at Caulfield Park Petanque Club, with singles, doubles and triples competitions held at the same venue over 4 days. Entries were good with participating teams from all over Australia New Zealand and Cambodia. It was as successful as the two previous events and this year the event will be held at Novar Gardens Club in Adelaide.

9. BUSINESS PLAN

This year we will be undertaking a complete review of our current business plan including looking at all our targets and having a good look at where we want to be in three years' time.

10. FINANCIAL REPORTING

During the year we continued to employ a bookkeeper and moved our accounting to the Xero software package which links directly to our bank accounts giving the bookkeeper better access to produce the monthly financial reports.

The Annual financial reports are bound in this report and you will see that we had a deficit this year due to the cost of hosting the Oceania Championships. However, we still completed the year a positive bank balance

Next year we will be projecting a surplus and getting back to normal

11. THE FUTURE

We will be working to improve our processes by investing in better software which will provide our membership better access to reporting and other information systems

We will also be working hard at promoting petanque throughout Australia working with clubs and leagues grow our membership.
